## **Tribunal Member – Keilor Basketball Association**

Applications are invited to join a panel of tribunal members for the Keilor Basketball Association Tribunal (KBA Tribunal). The panel will comprise multiple members, including a 'Chair,' with the KBA Tribunal convened on an anticipated weekly basis on weeknight evenings. The KBA Tribunal is an independent body of the Keilor Basketball Association (KBA) serving predominantly Keilor competitions. The Tribunal regulates the conduct of players, spectators and other persons reported by the KBA and its officials during or associated with junior and senior domestic basketball competitions.

### **Role Description:**

Each sitting of the KBA Tribunal will comprise three panel members with a designated 'Chair' responsible for regulating the proceedings.

The KBA and its officials are responsible for regulating junior and senior domestic basketball competitions in accordance with the Basketball Victoria (BV) Codes of Conduct, the KBA By-laws and policies. The KBA Tribunal, as an independent body, will hear reports from the KBA and its officials, submissions from the reported person and any witnesses, and then determine any sanction to be subsequently imposed by Basketball Victoria.

### **Key Responsibilities and Duties:**

The key responsibilities and duties of this role will be to:

- Uphold and abide by the Basketball Victoria Tribunal By-laws
- Receive, consider, and evaluate reports made by the KBA and its officials, submissions from reported persons and any witnesses and determine any sanction
- Hand down the determination either prior to the conclusion of the tribunal hearing or subsequently in writing to the KBA and notify Basketball Victoria.
- Determine sanctions that are commensurate with the reported conduct and that promote participation in basketball by the community
- Determine reports in a timely manner
- Comply with policies and practices set out by BV and the KBA.

To be a successful applicant, you will ideally possess:

- An interest in basketball and knowledge of the structure of community sport
- An understanding of the relationship between participants in basketball, officials, and sporting organizations
- An ability to evaluate reports and conduct hearings fairly and efficiently
- A demonstrable high standard of professional, personal integrity and impartiality
- Experience in human resources, basketball administration, or law enforcement/judiciary desirable.

### **Training:**

Basketball Victoria and Keilor Basketball will provide training for all tribunal members.
